

Privacy Policy for Learn and Earn

This Privacy Policy describes how Learn and Earn ("we," "us," or "our") collects, uses, stores, and protects your information when you use our website, www.learnandearn.io (the "Service").

By using our Service, you agree to the collection and use of information in accordance with this policy.

1. Information We Collect

We collect several types of information to provide and improve our Service for you.

Type of Information	Description
Personal Information	Identifiable data you provide voluntarily, such as name, email address, and payment information for account registration, course access, or customer support.
Usage Data	Automatically collected data on service interaction. Includes your computer's Internet Protocol (IP) address, browser type, pages visited, time and date of visit, and time spent on pages.
Tracking & Cookies	Cookies (small data files on your device) collect information and improve Service analysis. You can instruct your browser to refuse cookies, but some Service parts may then be inaccessible.

2. How We Use Your Information

The information we collect is used for the following purposes:

- **To Provide and Maintain the Service:** Including to monitor the usage of our Service.
- **To Manage Your Account:** To manage your registration as a user and provide you with different functionalities.
- **For Contract Performance:** To develop, comply with, and undertake the purchase contract for products, items, or services you have purchased.

- **To Contact You:** To contact you by email, telephone, SMS, or other equivalent forms of electronic communication for updates or informative communications related to the functionalities, products, or contracted services.
- **To Provide News and Offers:** To provide you with news, special offers, and general information about other goods, services, and events which we offer, unless you have opted not to receive such information.
- **To Manage Your Requests:** To attend and manage your requests to us.

3. Legal Basis for Processing (For EEA Users)

If you are from the European Economic Area (EEA), our legal basis for collecting and using your information depends on the context in which we collect it. We typically process your information because we have a contract with you, you have given us permission, it is in our legitimate interests and does not override your rights, or to comply with the law.

4. Sharing Your Information

We may share your personal information in the following situations:

- **With Service Providers:** We may share your personal information with third-party companies and individuals (e.g., payment processors, data analysts, customer support providers) to facilitate our Service, provide the Service on our behalf, or assist us in analyzing how our Service is used. These parties are obligated not to disclose or use your information for any other purpose.
- **For Business Transfers:** In connection with any merger, sale of company assets, financing, or acquisition of all or a portion of our business.
- **With Your Consent:** We may disclose your personal information for any other purpose with your consent.
- **For Legal Reasons:** To comply with a law, protect our rights, or prevent fraud.

We value your trust in providing us your Personal Information and strive to use commercially acceptable means to protect it. However, no method of transmission over the Internet or method of electronic storage is 100% secure and reliable, and we cannot guarantee its absolute security.

6. International Data Transfers

If you are located outside the United States and choose to provide information to us, please note that we transfer the data to the United States and process it there. Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

7. Your Data Protection Rights

- The right of rectification to correct inaccurate or incomplete information.
